

### Selected Case Summaries

**Damage allegation due to fraud and deceit affecting a subsidiary of a leading international insurance company in connection with a failed stock purchase -** We calculated the damages suffered by the company from not completing the purchase, determined the company's ability to fund the acquisition, and identified deficiencies with the issues raised by the defendant's expert.

**Arbitration disputing the methodology used to calculate the retrocessional recoveries arising from the events of September 11, 2001 -** We examined the accounting and related disclosures in the financial statements and prepared a rebuttal report.

**Audit committee investigation of potential fraud in the claims department and impact on loss reserves -** We investigated fraud allegations, identifying and analyzing significant data; created a data-analysis framework to categorize and analyze data contained in numerous systems and in various incompatible formats; analyzed reserve accounting and suggested modifications; and provided an actuarial expert to analyze reserves.

**State receivership action regarding the liquidation of an insurance carrier and allegations of improper auditing -** We provided research and guidance to counsel on insurance accounting and auditing issues; identified significant deficiencies in both assumptions and data used by the plaintiff's expert; calculated and substantiated significantly different financials; participated in deposition strategy and preparation; and provided an expert report.
