

Biosev S.A.

Brazilian subsidiary of the Louis Dreyfus Company group that operates eight agro-industrial units (sugarcane and co-generation)

SITUATION

The company went through a debt restructuring process as a condition precedent to an M&A transaction with Raízen (one of the leading energy conglomerates in Brazil). The transaction involved a complex structure with upfront cash payment and shares of the merged entity.

OUR ROLE

FTI Consulting was retained as financial advisor by the foreign lenders that were restructured based on the M&A proceeds:

- Performed financial due diligence on Biosev S.A. and assessed the fair value of the assets
- Built an operational and capital financial model to establish revenue projections and a business plan for the merged company
- Conducted an options analysis
- Actively engaged in the restructuring negotiations with Biosev, its advisors and Biosev foreign lenders

OUR IMPACT

FTI Consulting negotiated a deal that involved a substantial upfront payment and the remaining amount being paid with Raízen's shares sale and a capital injection from the holding company. The foreign lenders have been paid in full less than two years after the deal was closed.

OGX Petróleo e Gás Participações S.A

Brazilian upstream oil and gas company with production of 8,000 bop/d

SITUATION

Weak commodity prices, underperforming assets and high leverage resulted in OGX's restructuring under Brazilian bankruptcy law in 2013. One group of creditors, the OSX-3 bondholders, foreclosed on a FPSO chartered to OGX and obtained shares in the restructured OGX entity.

OUR ROLE

FTI Consulting was retained as financial advisor in 2017 by the OSX-3 FPSO vessel bondholders to restructure. As part of FTI Consulting's mandate, we reviewed and assessed the actions and plans put forward by OGX management to restructure the unpaid charter claim as well as an alternative plan for timely redelivery of the FPSO OSX-3 back to the bondholders. We identified and analyzed the issues that the bondholders would face in implementing a redeployment of the FPSO OSX-3 (e.g., regulatory, environmental, operational, economic). FTI Consulting advised the bondholders in electing a new OGX board (which in turn replaced OGX management) in order to facilitate the timely redelivery of the FPSO. We engaged with various bidders and negotiated the sale of the vessel.

FTI Consulting negotiated a short-term lease of the vessel with OGX which resulted in substantial upfront payments and charter fees for the bondholders. FTI Consulting concluded the mandate by advising the sale of OSX-3 bonds to a third party, resulting in a substantial cash payment to the bondholders.

Expert Witness Services in Brazil for Economic, Financial and Accounting Matters

Helping an arbitration tribunal in the quantum phase

SITUATION

A Brazilian distributor started an arbitration procedure against a foreign heavy machinery manufacturer, based on a breach of a distribution agreement in Brazil. A partial award was given in favor of the distributor and party-appointed experts presented damages using complex financial models and multiple assumptions. Their figures diverged greatly. The Tribunal found the need to have a courtappointed expert to help their understanding of the main issues around the damage calculations.

OUR ROLE

FTI Consulting was retained as the court-appoint expert to assess incurred costs and lost profits as a result of the breach of the distribution agreement. Our quantum of damages was based on the Tribunal decisions and took into account arguments made by the party-appointed experts. FTI Consulting calculated loss of profits by building a complex counterfactual scenario and comparing it to the actual results achieved by the distributor breach. We have validated more than 5,000 documents which supported costs incurred by the distributor. We issued two reports and provided oral testimony in two hearings to sustain the conclusions reached in the reports.

OUR IMPACT

We provided clear and concise information, summarizing complex economic and financial issues. Our detailed analyses were key for the Tribunal to (i) understand how the parties diverged in each of the key variables that drove quantum of damages; (ii) understand what was the reasonable scenario to be adopted; and (iii) to avoid double counting issues in the award.

Arbitration Support in Brazil

Post-acquisition dispute in the banking sector

SITUATION

Following the acquisition of a Brazilian bank by an international institution, the buyer initiated an arbitration procedure to claim for contingencies which materialized after the acquisition and which the buyer claimed were the seller's responsibility. The buyer claimed that information was not properly disclosed prior to closing and that an indemnification cap established in the SPA should be disregarded when calculating damages.

OUR ROLE

FTI Consulting was contacted by the Respondent's legal advisors and showed previous experience in similar engagements in Brazil. We were retained by the Respondent to act as expert witness, analyzing the claims visa-vis the supporting documentation, taking into consideration the SPA and calculating the value of materialized contingencies that could be considered the seller's responsibility based on the provisions established in the SPA. FTI Consulting prepared two expert reports, which explained our assumptions, instructions and calculations and clearly defined the variables that explained how our calculation diverged from the opposing expert's. We also provided oral testimony to the arbitral tribunal sustaining the conclusions reached in the reports.

OUR IMPACT

The Tribunal's decision was based on FTI Consulting's report. In the end, the Tribunal accepted more than half of FTI Consulting's suggested adjustments and the amount claimed by the buyer was significantly reduced, to a figure covered by the balance of an escrow account. This meant that the seller did not incur in any cash disbursements. Our analysis also proved that the seller did not withhold information on purpose so that the cap established in the SPA was maintained.

Cyberattack on a Brazilian Public Company

SITUATION

An important financial institution listed on the Brazilian Stock Exchange was a victim of a cyberattack known as ransomware, which completely paralyzed its operations. Their IT team carried out the backup restoration procedures successfully. However, as the company is listed, the external auditors requested an independent verification by a consultancy with proven technical capacity.

FTI Consulting was hired to identify the extent of the incident and method used by the attacker to circumvent the institution's security protocols, to present a technical report and to give recommendations for improving the security of the environment. We actively engaged in the restructuring negotiations with the company and its advisors.

SITUATION

Brazil's antitrust authority (CADE) determined the hiring of an independent monitor to evaluate the conditions under which it allowed the merger between two companies in the chemical sector to proceed.

OUR ROLE

SITUATION

Following a tragic plane crash in Colombia that killed 71 people in 2016, including Brazilian soccer players and sports journalists, a global company operating in the insurance and reinsurance market was on the receiving end of significant media coverage, a congressional investigation and lawsuits. The organization hired FTI Consulting to help protect its reputation throughout this ongoing crisis.

Addressing pressure from interest groups

SITUATION

Several petrochemical producers were facing increased reputational pressure due to a concerted effort from ethanol interest groups that were spreading falsehoods about the impact of the use of ethers in fuels. Given that this misinformation campaign was occurring around the time that the fuel specifications were being revised, the producer's license to continue to operate and commercialize its products in Mexico was being put in question.

FTI Consulting advised the Latin American Association of Efficient Combustibles on the creation of an issue-specific trade association that would lead the charge on setting the record straight. This trade association activated, expanded and equipped a wide-ranging coalition of environmentalists and environmental agencies who supported the use of ethers and opposed the use of alcohols, including ethanol. 


