I refer to the appointment of Kathryn Evans, Vaughan Strawbridge and I, Ben Campbell, as Joint and Several Administrators of the Companies on 6 March 2026.

**Notice of adjournment**

On 21 July 2026, the concurrent second meetings of creditors for each of the Companies ("the Meetings") were adjourned for up to 45 business days pursuant to section 75-140(3) of the Insolvency Practice Rules (Corporations) 2016 (*Cth*). The Companies will remain in voluntary administration while our asset realisation process for the Companies' assets continue to be realised in an orderly manner.

While the adjournment may be for up to 45 business days, we can reconvene the Meeting at any time by providing creditors with five (5) business days' notice. Notice will be provided to creditors by way of a supplementary report, which will provide:

- An update on the administration process;
- Options available for the Companies which creditors can vote on;
- Our analysis of the estimated financial outcome for each of the options available;
- Our recommendation to creditors for how to vote at the reconvened second meetings of creditors; and
- Details of the reconvened second meetings of creditors.
