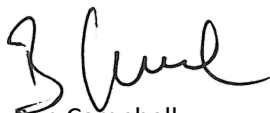
In order to participate in the dividend, creditors must provide updated bank account details, a completed formal proof of debt and supporting documents by **28 February 2023**.
