## **CIRCULAR TO CREDITORS AND MEMBERS**

## ELLUME LIMITED (SUBJECT TO DEED OF COMPANY ARRANGEMENT) ACN 141 767 660 ("the Company")

I refer to the appointment of John Park and I, Joanne Dunn, as Joint and Several Voluntary Administrators of the Company on 31 August 2022 and subsequently Deed Administrators on 22 December 2022.

I also refer to the Deed of Company Arrangement ("DOCA") proposed by Hough Consolidated Pty Ltd ("Hough") and accepted by Creditors on 20 December 2022.

## 444GA APPLICATION TO COURT FOR THE TRANSFER OF SHARES

A condition of the DOCA requires the Deed Administrators to obtain leave from Court for the transfer of all existing shares in the Company to Hough (or nominee) pursuant to Section 444GA(1)(b) of the Corporations Act 2001 (Cth). On 23 January 2023, the Deed Administrators filed an application with the Federal Court of Australia ("the Court") for the required leave ("444GA Application").

On 31 January 2023, the Court made an Order listing the 444GA Application for hearing on **22 February 2023 at 10:15AM AEDT** ("444GA Hearing") at the Federal Court of Australia located at 184 Phillip Street, Sydney NSW 2000, and for the Deed Administrators to give notice to each of the creditors and members of the Company of the following:

- the Originating Process;
- the Explanatory Statement;
- the affidavits of John Richard Park sworn on 20 January 2023 and 30 January 2023; and
- the orders made by the Court on 25 January 2023 and 31 January 2023 in relation to the 444GA Application.

The Explanatory Statement (enclosing the Independent Expert's Report and Court documents forming the 444GA Application) have been uploaded to the FTI Consulting Creditor Portal.
