- I am a Senior Managing Director in the Corporate Finance & Restructuring team of FTI. I
 am a Registered Liquidator and Chartered Accountant and have more than 25 years'
 experience in corporate finance and restructuring. I am experienced in acting as
 administrator in voluntary administrations of this type.
- 2. I am authorised to make this affidavit on behalf of the first applicant.
- Exhibited to this affidavit is a bundle of documents to which I refer and marked "JED-1" to "JED-6".

APPOINTMENT OF THE ADMINISTRATORS

- 4. On 17 March 2022, John Richard Park, Kelly-Anne Lavina Trenfield and I were appointed as joint and several administrators of Evolution Traffic Management Pty Ltd ACN 638 495 691 (the Company) (together the Administrators) pursuant to section 436A of the Corporations Act 2001 (Cth) (the Act).
- 5. A copy of an extract of the records maintained by the Australian Securities and Investments Commission (ASIC) dated 21 March 2022 is at "JED-1" to this affidavit.
- A copy of the ASIC Form 505 recording the appointment of the Administrators to the Company lodged 17 March 2022 is at "JED-2" to this affidavit.

PURPOSE OF APPLICATION


- 7. Unless extended, the convening period under section 439A(5)(a) of the Act will expire on 26 April 2022.
- 8. Since our appointment, the Administrators have continued to trade the Company to conserve its value for sale and allow for recapitalisation while undertaking our investigations.
- 9. I am of the view it would be in the best interests of the creditors of the Company for the convening period to be extended for a period of four weeks for the reasons outlined in this affidavit.
- 10. In those circumstances, I make this affidavit in support of an application filed by the Administrators on 14 April 2022 seeking an order pursuant to section 439A(6) of the Act that the period to convene the second meeting of the second applicant be extended and related orders.

THE COMPANY'S BUSINESS OPERATIONS

- 11. The Company provides complete traffic management services to various entities including local councils, road maintenance and construction contractors, state road authorities, utility providers and civil engineering contractors. The Company's services include:
 - (a) Traffic management planning, site management, traffic control, traffic equipment hire and traffic data services;
 - (b) Liaising with road authorities in respect of (a) above; and
 - (c) Accredited traffic management and safety induction training courses (via a related entity, explained further below).
- 12. The Company has over 400 public and private sector clients.
- 13. The Company is a 100% owned subsidiary of Evolution Group Holdings Limited ACN 147 834 133 (EGH) and contributes about 82% of the annual revenue for EGH, which is circa AUD\$102.3 million.
- 14. EGH is a leading Australian and New Zealand traffic management services provider with its headquarters in Brisbane. A visual representation of the EGH corporate group is as follows:

15. EGH is a substantial company. Across the EGH corporate group in Australia, staff and fleet numbers are as follows:

- 16. A summary of the functions of the key entities in the EGH corporate group, other than the Company, is as follows:
 - (a) EGH provides the wider EGH group with a range of corporate services such as insurance services, information technology services and human resources.
 - (b) Evolution Civil Maintenance Pty Ltd ACN 140 124 858 (ECM) contributes approximately 14% of EGH's revenue and specialises in roadside guardrail and safety barrier installation and maintenance, bridge and road maintenance and rehabilitation, including concrete repair and strengthening, waterproofing systems and expansion joint installation and maintenance. Based on investigations to date, the Administrators understand that most projects undertaken by ECM necessarily require traffic management services of the Company.
 - (c) Evolution Fleet Services Pty Ltd ACN 132 010 596 contributes approximately 3% of EGH's revenue and is a national fleet management services business, specialising in providing vehicles to the infrastructure, construction, utilities and government sectors throughout Australia. It has a fleet of over 280 vehicles ranging from standard passenger and commercial vehicles through to fully equipped site compliant vehicles.

- (d) Evolution Training and Safety Pty Ltd ACN 130 554 228 (ETS) contributes approximately 1% of EGH's revenue and is a registered training provider authorised to deliver nationally recognised vocational education and training courses. ETS provides the necessary training for the Company's staff.
- (e) Evolution Asset Management Pty Ltd ACN 109 296 746 (EAM) owns the vehicles which allow the Company to undertake projects and deliver services. Based on investigations to date, the Administrators understand that the Company makes all payments for these vehicles including registration, fuel, maintenance and other usual running costs, and then pays EAM for the Company's use of the vehicles. It is estimated that the vehicles owned by EAM have a fair market value of approximately AUD\$19.25 million.
- 17. The size and structure of the EGH corporate group complicates the administration process, including, because of the cross-entity services provided within the corporate group.

FINANCIAL POSITION OF THE COMPANY

- 18. As at the date of the Administrator's appointment, to the best the Administrators can presently ascertain, the Company's revenue was AUD\$65.2 million.
- 19. The Administrators' initial enquiries have established that the secured creditors of the Company are owed in the vicinity of AUD\$20.6 million, priority creditors are owed in the vicinity of AUD\$2 million, and the unsecured creditors are owed in the vicinity of AUD\$14.6 million (excluding intercompany creditors). The Administrators' investigations are continuing, therefore these figures are subject to change.
- 20. Attached and marked "JED-3" is a list of creditors of the Company that are currently known to the Administrators.

FIRST MEETING OF CREDITORS

- 21. On 18 March 2022, the Administrators caused a combined notice of appointment and first meeting of creditors to be published on the ASIC published notices website.
- 22. Attached and marked "JED-4" is a copy of the notice published on the ASIC notices website.
- 23. On 29 March 2022, the Administrators conducted the first meeting of the Company's creditors via video conference (the First Meeting of Creditors). I acted as chairperson of the First Meeting of Creditors. The questions raised by creditors of the Company are recorded in the minutes of the meeting.

24. Attached and marked "JED-5" and "JED-6" is a copy of the minutes of the First Meeting of Creditors and a schedule of creditors who attended, respectively.

EXTENSION OF THE CONVENING PERIOD

- 25. As at the date of this affidavit, the Administrators have identified that the Company's financial difficulties arose due to its financial management, specifically the management of the Company's accounts receivables.
- 26. The Administrators have identified a number of voidable transactions which may be pursued by a liquidator for the benefit of creditors however further investigation is required to establish collectability.

Work performed to date

- 27. Since our appointment, the Administrators have undertaken investigations in accordance with section 438A of the Act, including, but not limited to:
 - (a) Identified as many of the creditors of the Company as possible in as short a timeframe as possible.
 - (b) Identified and contacted the holders of security interests registered against the Company on the Personal Property Securities Register (PPSR), including reviewing security agreements and considering priority of creditors.
 - This included liaising the National Australia Bank Limited (NAB) and Cashflow Finance Australia Pty Ltd (CFA) in relation to their respective all present and after acquired property registrations on the PPSR.
 - (c) Identified and reviewed the accounting systems, processes and controls of the Company.
 - (d) Obtained access to systems remotely and contacted external systems providers to obtain backups of Company records and systems.
 - (e) Conducted searches to establish assets owned by the Company and any outstanding legal action against to the Company.
 - (f) Requested records from auditors, accountants, and legal representatives.
 - (g) Made a request under the Freedom of Information Act to obtain taxation records of the Company from the Deputy Commissioner of Taxation.
 - (h) Analysed historical trading results and prepared forecasts for the Company to facilitate ongoing trade.

- (i) Dealt with issues relating to the employment of the Company's employees, obtained employee records and commenced calculations of outstanding employee entitlements.
- (j) Dealt with ongoing and new contracts for traffic control so that the Company may continue to trade.
- (k) Negotiated and secured a variation to the existing debtor financing facility with CFA so that the Company may continue to trade.
- (I) Investigated the effect of the appointment of the Administrators on licensing requirements for traffic controllers in Queensland.
- (m) Identified the relationship between various entities within the EGH corporate group, including understanding the operations of each entity providing services to the Company.
- (n) Undertaken investigations in relation to assets of the Company.
- 28. In addition to the above investigations, the Administrators have:
 - (a) Produced and lodged with ASIC the required documentation in respect of:
 - (i) The appointment of the Administrators; and
 - (ii) The convening of the First Meeting of Creditors.
 - (b) Notified the Australian Taxation Office and other government bodies of the appointment of the Administrators and attended to registration for goods and services tax purposes.
 - (c) Corresponded with the Company's insurance broker and obtained insurance coverage and relevant notifications on policies held to reflect the Administration.
 - (d) Liaised with workers compensation insurers in QLD, NSW and WA and other insurers relating to ongoing claims.
 - (e) Corresponded with the landlords and suppliers to maintain the Company's current trade and ensure the value of the business with key stakeholders has been preserved.
 - (f) Corresponded with landlords regarding ongoing tenancy arrangements and requests to vacate premises.
 - (g) Executed new lease documentation for premises at Toowoomba following vacation of the existing depot.

- (h) Corresponded with CFA and taken steps to have amounts owing to CFA as at the date of the Administrators' appointment paid out.
- (i) Corresponded with NAB in relation to its debt, estimated to be circa AUD\$18 million (the NAB Debt).
- (j) Prepared for and held the First Meeting of Creditors, which included:
 - (i) Identifying the creditors of the Companies
 - (ii) Preparing the relevant notices;
 - (iii) Collecting informal proofs of debt and proxies for the purposes of voting at the meeting;
 - (iv) Preparing and attending to lodgement with ASIC of the minutes of the First Creditors Meetings.
- (k) Prepared for and launched a process for the sale of the Company's business, including providing for access to a data room.
- (I) As part of the sale process, engaged with 25 parties, 19 of which signed non disclosure agreements and received information memorandums, and received 4 expressions of interest.

Further work required and why it will benefit creditors

- 29. Notwithstanding the work outlined in paragraphs 27 and 28 above, further work is required to properly investigate the Company's business, property, affairs and financial circumstances, including:
 - (a) The completion of the sale of business campaign currently being undertaken. The Administrators do not anticipate that process concluding until at least the end of April 2022. Additional time will allow the Administrators to negotiate with interested parties and relevant stakeholders to generate a potential going concern sale. If, however, the Company's business and/or assets are not sold, the extension sought will allow the Administrators more time to conduct any sale and an orderly wind-down of the Company's operations (should the Administrators be the liquidators).
 - (b) Reviewing offers in relation to the sale of the Company's business and negotiating with interested parties.
 - (c) As part of the sale or recapitalisation of the business of the Company, on 12 April 2022, a deed of company arrangement (DOCA) was proposed. Further time will be required for the DOCA proposal to be reviewed, further developed,

- negotiated, considered and then presented to the creditors along with the Administrators' recommendation for their approval at the second meeting, especially in the circumstances described in (d) below.
- (d) The continuing discussions regarding NAB's security and, specifically, the prospect of a refinance of the NAB Debt. If the NAB Debt is refinanced, I consider it may generate a better outcome for creditors because it would allow for the Company to restructure its debt and importantly, recapitalise. Additional time will allow the Administrators to negotiate with interested parties and relevant stakeholders in an attempt to achieve that refinance.
- (e) Continued investigations in relation to intercompany and related creditors.
- (f) Finalising calculations with respect to employee entitlements.
- (g) Negotiating and entering into new leases for the Company to store its property to enable it to continue trading.
- 30. Given the stage of the administration, the expressions of interest which require significant further information to convert to binding offers, and the DOCA proposal which requires further development, the Administrators are presently unable to provide any meaningful recommendation or proposal to creditors as required under section 439A of the Act in respect of the future of the Company.
- 31. If further investigations identify activity that may give rise to any actions which the Administrators may pursue, the Administrators will seek legal advice before commencing proceedings.
- 32. Given the size and complexity of the Company's affairs, I consider a period of up to four weeks from 26 April 2022 is necessary to enable the Administrators to properly investigate the business, property, affairs and financial circumstances of the Company, provide required information to interested parties and to obtain a DOCA proposal in a form where a meaningful recommendation to creditors is possible.

No perceived detriment to creditors

- 33. The Administrators continue to meet employees' entitlements during the period in which the Company continues to trade and expect to be able to do so for the extended time sought.
- 34. The Administrators continue to meet all approved supplier expenses incurred during the period in which the Company continues to trade. Further, the extended time sought will likely increase the possibility of a return to all unsecured trade creditors.

- 35. Based on all the reasons stated above, I believe that it is in the best interests of the creditors and members of the Company for the orders sought in the application to be made. I do not believe any interested persons will be unfairly prejudiced by the orders sought in the application.
- 36. I consider the extension is likely to increase the possibility of a greater return to the majority of creditors by allowing the Administrators to secure a buyer or recapitalise the Company's business for continued operations.
- 37. All the facts and circumstances above deposed to are within my knowledge, save such as are deposed to from information only, and my means of knowledge and sources of information appear on the face of this my affidavit.

- Participants using the electronic facilities were taken to be present in person at the meeting pursuant to IPR 75-75 and were included in the record of persons present which will form part of the minutes of the meeting and lodged with ASIC.

VIRTUAL MEETING LOGISTICS

The Chairperson provided the following information to creditors as to how the virtual meeting would be run:

- There would be an allocated time for the Administrators to respond to questions submitted. At that time, creditors will be asked to unmute themselves to ask questions verbally.
- Creditors were encouraged to use the Q&A and chat functions in Zoom to submit questions at any time during the meeting to be answered at the appropriate time.
- Creditors attending via phone were provided instructions on how to raise their hand and mute and unmute their phones.

The Chairperson noted she had received proofs of debt and proxies for the meeting. The Chairperson advised:

- Proofs of debt had been assessed in accordance with IPRs 75-85 –

The Chairperson advised she would not use any general proxy to vote in favour of any resolution which would place her, her partner or employer in a position to receive any remuneration (directly or indirectly) out of the assets of the company pursuant to IPR 75-97.

QUORUM

The Chairperson advised a quorum was present pursuant to IPR 75-105 as at least two creditors were present at the meeting in person, by proxy, by power of attorney or participating via electronic means.

NOTICE OF MEETING

The Chairperson advised the meeting had been called in accordance with the Notice of Meeting dated 21 March 2021 sent to all known creditors on 21 March 2021 in accordance with IPRs 75-10 – 75-25.

The Chairperson also advised creditors the notice was published on the ASIC Insolvency Notices website in accordance with IPR 75-40.

The Chairperson tabled the notice of meeting via electronic means.

DECLARATION OF CONVENIENCE

The Chairperson declared the meeting was convened at a time and place convenient to the majority in number of creditors in accordance with IPR 75-30.

DIRRI

The Chairperson tabled the Declaration of Relevant Relationships and Indemnities (DIRRI) which was lodged with ASIC and included in the Initial Circular to Creditors.

PURPOSE OF MEETING

The Chairperson advised the purpose of the meeting was to provide a brief history of the company and the background to the appointment.

The meeting would also determine:

- Whether to appoint a committee of inspection; and
- m If so, who the committee's members will be.

At the meeting, creditors may also, by resolution:

- Remove the administrator from office; and
- Appoint someone else as administrator of the company.

General business could also be discussed.

VOLUNTARY ADMINISTRATION PROCESS

The Chairperson tabled the Initial Circular to Creditors and advised of the following:

- John Park, Kelly-Anne Trenfield and herself were appointed as administrators on 17 March 2022.
- This meeting is the First Meeting of Creditors held on 29 March 2022.
- The deadline for non-binding expressions of interest in relation to the sale of the business is 8 April 2022.
- 2 12 April 2022 is the deadline for any proposals for a Deed of Company Arrangement.

- The deadline for stage two binding offers in relation to the sale of the business is 14 April 2022.
- The Administrators will issue their second report to creditors on or before 22 April 2022.
- The Administrators intend to hold the second meeting of creditors on or before 4 May 2022. At this meeting creditors will decide whether
 - The Company should be wound up;
 - The Company should execute a Deed of Company Arrangement;
 or
 - The administration should end.

BACKGROUND INFORMATION

The Chairperson advised creditors that the information provided to creditors in this meeting is based on Company records, the accuracy of which cannot be verified.

The Chairperson advised that:

- The Administrators have necessarily relied upon the Company's records to date to provide a snapshot of the business to date as of the day of this meeting.
- The Administrators, at this stage, cannot warrant the accuracy of the information presented. However, it was noted that the next report will provide increased accuracy
- · This is only a broad overview of what has been discovered to date
- Further investigations will be conducted over the course of the next few weeks.

The Chairperson provided the following background on the Company:

- m The Company was incorporated on the 15 January 2020.
- The Company is a wholly owned subsidiary of Evolution Group Holdings Limited.
- The Company is Evolution Group Holding Limited's core business, generating the majority of revenue through providing a comprehensive range of traffic management services and supports processes including traffic management planning, site management and traffic control, hire and data services.
- the Company operates from a number of locations along the east coast of Australia and in Perth.
- The Company employs 702 employees who are a mixture of casual, part time and full time.
- A Director has advised the reasons for the failure of the Company was due to poor management of accounts receivable and the business being undercapitalized and over-leveraged.

- Over the course of the next few weeks the Administrators will conduct investigations and advise creditors of our preliminary review as to the failure of the company.
- As the Directors believed the company was insolvent or likely to become insolvent, they appointed the Voluntary Administrators on 17 March 2022.

ACTIONS TO DATE

The Chairperson informed creditors the Administrators have continued to trade the Company on a "business as usual" basis following their appointment with a view to achieving a sale or recapitalisation of the Company via a deed of company arrangement. As part of trading the business the Administrators have undertaken tasks including:

- Establishing supplier accounts;
- Paying employee wages;
- Opening a new debtor factoring facility with Early Pay;
- Issued circulars to employees via email and SMS communicating the Company is continuing on a "business as usual" basis;
- Facilitating daily townhalls with staff to answer employee questions;
- Liaising with staff regarding entitlements owed to employees;
- Identifying the Company bank accounts and inventory;
- Reviewing outstanding debtors and liaising with the debtor finance provider for release of funds under the debtor factoring facility; and
- Commencing investigations.

The Chairperson mentioned obtaining the records of the company is vital to investigations.

SALE OF BUSINESS AND DEED OF COMPANY ARRANGEMENT

The Chairperson discussed the sale of business campaign underway and advised of critical timeframes for offers and Deed of Company Arrangement proposals to be received.

The Chairperson advised creditors:

- The business was advertised for sale or recapitalisation in the Australian Financial Review on 25 March 2022;
- To date, the Administrators have received interest from 7 parties, of which 2 having already signed non-disclosure agreements;
- It is anticipated an information memorandum will be issued in the next 2 days and access to the data room will be provided to prequalified parties on 4 April 2022;
- Stage 1, non-binding indicative offers are due 8 April 2022 with preferred bidders required to submit binding offers no later than 14 April 2022;

- The Administrators are aware there may be parties interested in putting forward a Deed of Company Arrangement and should anyone be interested they are requested to submit their proposal by 12 April 2022;
- Any proposal/s or offer/s will be assessed and summarised in the second report to creditors to be issued on or before 22 April2022. This second report will set out the Administrators opinion on whether it is in creditors best interest for the deed of company arrangement proposal to be accepted or if an offer for sale should be accepted.

ASSETS AND LIABILITIES

The Chairperson advised creditors of the assets and liabilities of the Company at the date of appointment from information obtained to date from books and records of the Company.

QUESTIONS AND ANSWERS

The Chairperson asked the meeting if there were any questions and reminded creditors asking questions to identify themselves and the creditor they represent.

- Pratap Subramanian representing The Trustee for the Adaptive Trust t/as Southland Supply Group asked:
 - What are the requirements if we have a couple of open orders with the company?

The Chairperson informed Mr Subramanian there is a team handling the trading aspects of the Company and she would get a member of staff to contact him directly.

Prior to the meeting, Reeves D'Souza, as a representative for the Deputy Commissioner of Taxation, raised numerous questions. These questions were addressed by the Chairperson prior to the meeting via email. A schedule of these questions and answers are included in Appendix C to the minutes of meeting.

There were no further questions raised.

VOTING

The Chairperson advised a creditor could not vote in respect of a debt which is unliquidated, contingent or whose value has not been ascertained unless a just estimate of its value has been made in accordance with IPR 75-85 (4).

Creditors holding security over the assets of the Company can vote without surrendering their security. The Chairperson has the power to admit or reject a Proof of Debt for the purpose of voting under IPR 75-90.

The Chairperson advised the meeting votes will be taken on a show of hands unless a poll is requested.

In accordance with IPR 75-115 a resolution will pass under a poll when:

A majority in number and a majority in value of creditors is required for the resolution to pass.

Related creditors with assigned debts will be limited in value to the consideration given for the assigned debts.

The Chairperson advised she will vote her general proxies as appropriate or special proxies as directed. She will not use a general proxy to vote in favour of any resolution which would place her, her partners or employer in a position to receive any remuneration (directly or indirectly) out of the assets of the company pursuant to IPR 75-97.

If there is not a majority in both number and value, then no result is reached.

If no result is reached, as Chairperson, she may exercise a casting vote in favour of the resolution or against the resolution or may abstain.

The Chairperson advised they will not exercise a casting vote in relation to remuneration and will not vote against a resolution relating to the removal of the Administrators pursuant to IPR 75-115(4).

They will inform the meeting of any reasons for exercising, or not exercising a casting vote and it will be included in the minutes pursuant to IPR 75-115(6).

RESOLUTIONS

The Chairperson noted there were resolutions on certain matters they would be putting to the meeting and persons participating and able to vote would also be able to propose and amend proposed resolutions in accordance with IPR 75-70.

If a person participating proposes a resolution, they should advise the meeting of their name and the creditor they represent.

The Chairperson advised that reasonable time would be allowed to debate any proposed resolution or amendments before putting the resolution or amended resolution to a vote.

The Chairperson advised that the resolutions are in relation to deciding to appoint a Committee of Inspection and/or to appoint a different Administrator.

COMMITTEE OF INSPECTION – TRADING SUPPLIERS

The Chairperson advised the meeting that they may resolve to appoint a Committee of Inspection ("COI") whose role would be to monitor the Administration and give assistance to the Administrators.

The COI would meet as required and have certain rights to give directions, receive information and obtain specialist advice or assistance if appropriate.

Creditors and employees have the right to appoint members to a committee if established.

However, large creditors (individually or collectively) with greater than 10% of the total claims or employees (individually or collectively) with greater than 50% of total employee entitlements claims in value against the company should not participate in the main vote if they intend to exercise their right to appoint members directly to the committee if established.

The Chairperson noted that prospective members should be aware that there are restrictions on members of a committee (or their related parties) deriving a profit or advantage from the company (other than a dividend), the administration or a creditor, unless:

- The creditors resolve otherwise; or
- It is permitted by the Corporations Act or another law; or
- The court gives leave.

These are offences of strict liability against the members.

The Chairperson noted that if the creditors choose to establish a COI, then they also intended to propose a resolution that would permit arm's length transactions in the ordinary course with members of the committee and the Company or its creditors, to address the requirements of IPS 80-55 and ensure that normal arm's length transactions did not result in a breach of the strict liability offence.

The Chairperson further explained, if a supplier were to become a member of the COI, a resolution would be proposed which would allow the Administrators to continue trading with that supplier and consequently not commit an offence against the Corporations Act.

APPOINT COMMITTEE OF INSPECTION

The Chairperson asked creditors whether there was any interest in the formation of a Committee of Inspection.

There was no interest in the formation of a Committee of Inspection.

The Chairperson advised creditors they would have another opportunity to form a COI at the second meeting of creditors if resolved.

REPLACEMENT OF ADMINISTRATORS

The Chairperson advised in accordance with Section 436E of the Act, creditors may, appoint someone else as Administrator of the Company.

The Chairperson noted no consent to act or DIRRI had been received to replace the Administrators.

The Chairperson asked creditors whether they wished to appoint someone else as Administrator and if so, whether any creditor was in possession of a DIRRI and Consent to Act from another practitioner.

There was no interest to appoint alternative Administrators and therefore The Chairperson confirmed John Park, Kelly-Anne Trenfield and herself, Joanne Dunn, would remain Administrators of the Company.

GENERAL BUSINESS

The Chairperson went through the next steps of the Administration, namely:

- The Administrators would continue to operate the business;
- Investigations into the affairs of the Company would be progressed;
- The Second Report to Creditors will be issued on or before 22 April 2022; and
- The Second Creditors Meeting will be held on or before 4 May 2022, where creditors will vote on the future of the Company, and that creditors will be advised of the details in due course.

The Chairperson asked if there were any further questions. No further questions were raised.

CLOSURE

There being no further discussion, the Chairperson declared the meeting closed at 1:25PM.

Question

Based on your investigation to date, has the entity complied with its superannuation obligation?

Can the administrator advise if Evolution Traffic Management ACN 638495691 provide its services to a related party?

What is the trade receivables position for ETM?

Can the administrator elaborate on the basis of the DOCA (if intended) on the matter?

As, Evolution Traffic Control Pty Ltd ACN 109656233 (subject to DOCA) and Evolution Traffic Management Pty Ltd ACN 638495691, are part of the Evolve group, are the two companies reporting consolidated financial statements under Evolution Group Holdings Limited ACN 14783413? Is there any transaction that has been identified on the Evolution Group Holding Limited financial statements?

is there any prior intercompany loans or transaction between the company, understanding that you are ensuring that the transaction are conducted at arms -length

Answer

- J. Dunn: We understand the entity has paid all superannuation obligations up to and including for the December quarter 2021
- J. Dunn: ETM does provide some services to related entities, similarly related entities provide services to ETM. Whilst the Administrators are trading the business of ETM, we are putting in place protocols to ensure such transactions are conducted on an arms-length basis.
- J Dunn: We will disclose this at the meeting, however the net position is ~\$5.2m (after taking into account the debtor finance facility)
- J Dunn: Although the directors have advised they intend to submit a DOCA proposal, at this stage, we are not aware of the details. We have requested any DOCA proposal to be submitted on or before 12 April 2022.
- J Dunn: We understand EGH reports the operations of the Evolution Group on a consolidated basis when it lodges its financial statements with ASIC. Can you please provide further clarity on the second question you have raised?

J Dunn: I assume you are referring to the sale of ETC to ETM? If so, this transaction will form part of our investigations. I also understand creditors of ETC received details of the Administrators' review in the 2nd VA report.

Question

Is there an ASIC registered Deed of Cross guarantee between the companies?

How is the Administrator going to elevate the perceived lack of independence of the Administrator on the matter; being aware that Evolution Traffic Control Pty Ltd ACN 109656233 (under DOCA has not finalised)?

What is the role of Vantage Performance with the entity, and how long has Vantage Performance has been involved on the matter?

Is Vantage Performance advisors to the Directors' personally as well?

Has the administrator identified a D&O policy and If any claims can be identified against the Director or advisors for breach of duty?

Answer

J Dunn: We are not aware of an ASIC registered Deed of Cross Guarantee.

J Dunn: We do not consider there is either a perceived or actual lack of independence. The ARITA Code of Professional Practice, Chapter 3 specifically refers to situations where Administrators can accept appointments in respect of group entities and the requirements involved. We have also outlined this prior involvement in our DIRRI, at length, and have no reservations around our independence.

J Dunn: We understand Vantage Performance were a financial advisor to the entity. We are happy to raise this matter with Vantage and to confirm with you.

J Park: I confirm I have now spoken with Vantage. They do not act for the Directors of the Company.

J Dunn: We are unaware of a D&O Policy, but it will be subject to our further investigations. Breaches of Director duty will be incorporated into our 2nd VA report as our investigations have only just commenced.
