**CIRCULAR TO CREDITORS
GLOBAL EVERGREENING ALLIANCE LIMITED (IN LIQUIDATION)
ACN 626 042 813 ("GEA")**

I refer to previous correspondence regarding GEA and in particular the Liquidators' Circular to Creditors dated 2 July 2026 advising that GEA was wound up and placed into Liquidation from 2 July 2026.

Contracts and/or agreements with GEA

Given GEA's financial position and the appointment as Liquidators, all activities undertaken by GEA have ceased immediately upon the appointment of Liquidators (with the exception of the feasibility study being undertaken in Vietnam which is subject to a funding arrangement), and all employees of GEA have been terminated because of redundancy.

Accordingly, all contracts and/or agreements entered into with GEA prior to the appointment of the Voluntary Administrators on 23 March 2026 are effectively terminated and the Liquidators (including in their capacity as former Voluntary Administrators) are not required to perform under the terms of those contracts and/or agreements.

The Liquidators (including in their capacity as former Voluntary Administrators) expressly advise that that have not and do not personally adopt any pre-appointment contract and/or agreement with GEA, and they are not personally liable (other than as required by law) with respect to the contracts and/or agreements.

Any claims that you consider you may have following the Liquidation of GEA is an unsecured claim against GEA and not the Liquidators (or Administrators) personally, and they do not accept liability with respect to same.

Supplier Accounts

Please provide outstanding invoices and a final statement for goods and services relevant to the Administration period (i.e. post 23 March 2026 to 1 July 2026) as a matter of priority to GEA@fticonsulting.com.

This does not affect suppliers providing services to GEA's leased premises at 12/24 Lakeside Drive Burwood East VIC 3151 who will receive separate correspondence by the Liquidators, or certain suppliers who have already received separate correspondence from the Liquidators regarding ongoing services during the wind down period.

Suppliers are advised that the Liquidators only accept liability for goods and services that have been validly approved by the Liquidators (i.e. the Administrators) and their authorised representatives.
