The purpose of the meeting is:

- 1. To review the Administrators' Supplementary Report and their recommendation in connection with the business, property, affairs and financial circumstances of the Companies; and
- 2. For the creditors of the Companies to resolve on whether:
  - a) the Companies be wound up; or
  - b) the Administration should end,
- 3. For creditors of the Companies to vote on the remuneration to be paid to the Voluntary Administrators and future Liquidators as calculated on a time basis for the periods:
  - a) 8 July 2024 to 8 September 2024 (inclusive);
  - b) 9 September 2024 to 20 September 2024; and/or
  - c) 21 September 2024 to finalisation of liquidation.
- 4. If the Companies are placed into liquidation, to consider the appointment of a Committee of Inspection and if required, to determine the members; and
- 5. Any other business properly brought before the meeting.
