- Richard Hughes and Grant Sparks of Deloitte as General Purpose Administrators of the Companies on 24 March 2023 ("Former Administrators");
- Ben Campbell and I, John Park, as Special Purpose Administrators of IGPC on 29 January 2024; and
- Ben Campbell and I, John Park, as General Purpose Administrators of the Companies on 27 June 2024 ("Administrators").

Update on the Administration of the Companies

Sale and/or recapitalisation and funding of the Administration

Following our appointment, the Administrators engaged Houlihan Lokey as sale advisors to assist the Administrators in running a competitive market-testing process to confirm interest in:

- Funding proposals for the Administration; and
- A sale and/or recapitalisation of all or some of the Companies or any of their assets.

As a result of this process:

- a funding agreement was entered into between IGPC and Sev.en Global Investments a.s on 20
 August 2024;
- the Administrators caused IEHA to enter into a confidential sale transaction on 12 October
 2024, which is subject to certain conditions; and
- the Administrators caused IGPC to enter into a confidential sale transaction on 18 October 2024, which is conditional on the Administrators seeking and obtaining a judicial direction in respect of the transaction ("Judicial Direction").

Investigation into the Callide C Incidents

Following appointment as Special Purpose Administrators to IGPC and throughout our appointment as General Purpose Administrators of the Companies, the Administrators have continued their investigations into the Callide C incidents. Over fifty (50) individuals have been publicly examined, considerable documents produced subject to summonses, and experts engaged to assist with the investigations and quantify the potential losses suffered by IGPC as a result of the Callide C incidents.

Further public examinations are being conducted on 24 and 25 October 2024.

Intention to extend the convening period

As Administrators, we are required to hold two (2) meetings of creditors in respect of the Companies:

- The first meeting, which was held by the Former Administrators on 5 April 2023; and
- The second meeting, at which creditors vote on the future of the Companies. This meeting must be convened within 20 business days after appointment ("the Convening Period"), or such time as extended, and the meeting held within five (5) business days before, or after, the end of the Convening Period, being (currently) on or before 7 November 2024 ("the Second Meetings of Creditors").

Prior to the Second Meetings of Creditors, the Administrators are also required to prepare their Second Report to Creditors. Subject to the Court application, referred to below, the Second Report to Creditors is to be issued on or before 31 October 2024.

Court Application

The Administrators hereby give notice that on 22 October 2024 the Administrators filed an interlocutory application with the Federal Court of Australia ("Application"). The Application seeks orders under sections 439A and 447A of the *Corporations Act 2001* (Cth) ("Corporations Act") and section 90-15 of the *Insolvency Practice Schedule (Corporations)*, being Schedule 2 to the Corporations Act and the inherent jurisdiction of the Court extending the convening period for the Companies until 6 December 2024, in respect of the Judicial Direction and certain other ancillary orders. An unsealed copy of the Application is **enclosed**.

The Application is listed to be heard on 24 October 2024 before the Honourable Justice Derrington at 9:30am AEST. The hearing will take place at:

A. DETAILS OF APPLICATION

This application is made pursuant to sections 439A, 447A of the *Corporations Act 2001* (Cth) (**Corporations Act**) and 90-15 of the *Insolvency Practice Schedule (Corporations)* (**IPSC**), being Schedule 2 to the Corporations Act, and the inherent jurisdiction of the Court.

On the facts stated in the supporting affidavit of John Richard Park affirmed on 22 October 2024 (**Park Affidavit**), the Plaintiffs apply for the following relief.

Judicial Direction

- 1. A direction that the First Plaintiffs (**Administrators**) in their capacity as joint and several administrators of the Fifth Plaintiff (**IGPC**):
 - (a) were justified and otherwise were acting reasonably in causing IGPC to enter into the [(Transaction); and
 - (b) would be justified and otherwise be acting reasonably in causing IGPC to complete and otherwise perform its obligations under the Transaction.

Convening period

2. Pursuant to section 439A(6) of the Corporations Act the convening period (as defined in section 439A(5)(b) of the Corporations Act) within which the First Plaintiffs must

- convene the second meeting of creditors in respect of the Second to Fifth Plaintiffs be extended up to and including 6 December 2024.
- 3. Further or alternatively to prayer 2, pursuant to section 447A of the Corporations Act, Part 5.3A of the Corporations Act is to operate in relation to the Second to Fifth Plaintiffs as if, notwithstanding the provisions in section 439A of the Corporations Act, the convening period of the Second to Fifth Plaintiffs was the period up to and including 6 December 2024.
- 4. Pursuant to section 447A of the Corporations Act, Part 5.3A of the Corporations Act is to operate in relation to the Second to Fifth Plaintiffs as if, notwithstanding the provisions in section 439A of the Corporations Act, the second meeting of the creditors of the Second to Fifth Plaintiffs required under section 439A of the Corporations Act may be convened and held at any time during, or within, the convening period as extended under prayers 2 or 3 above, provided that the Administrators give notice of the meeting to creditors of the Second to Fifth Plaintiffs at least five business days before the meeting.

Confidentiality

- 5. Until the conclusion of the external administration of the Second to Fifth Plaintiffs, or further order of the Court, pursuant to section 37AF of the Federal Court of Australia Act 1976 (Cth), on the ground stated in section 37AG(1)(a), being that the order is necessary to prevent prejudice to the proper administration of justice:
 - (a) Confidential Exhibit JRP-6 to the Park Affidavit;
 - (b) those parts of this Interlocutory Process that are shaded in grey; and
 - (c) any written submissions relied upon by the Plaintiffs on this application to the extent they refer to the content of Confidential Exhibit JRP-6,

be kept confidential and not be provided or disclosed to any person other than:

- (d) any Judge of this Court, and that Judge's staff and assistants;
- (e) the Plaintiffs and their legal representatives; and
- 6. Until the conclusion of the external administration of the Second to Fifth Plaintiffs, or further order of the Court, pursuant to section 37AF of the Federal Court of Australia Act 1976 (Cth), on the ground stated in section 37AG(1)(a), being that the order is necessary to prevent prejudice to the proper administration of justice:
 - (a) Confidential Exhibit JRP-7 to the Park Affidavit;
 - (b) those parts of this Interlocutory Process that are shaded in grey; and
 - (c) any written submissions relied upon by the Plaintiffs on this application to the extent they refer to the content of Confidential Exhibit JRP-7,

be kept confidential and not be provided or disclosed to any person other than:

- (d) any Judge of this Court, and that Judge's staff and assistants;
- (e) the Plaintiffs and their legal representatives; and

Other orders

- 7. Any person who can demonstrate a sufficient interest to discharge or modify these orders has liberty to apply on 3 business days' written notice to the Plaintiffs and the Court.
- 8. An order that the Administrators have liberty to apply on 1 business days' notice, specifying the relief sought.
- The Plaintiffs' costs of and incidental to this application are to be treated as costs in the administration of the Second to Fifth Plaintiffs and be paid out of the assets of the Second to Fifth Plaintiffs.
- 10. Any further or other order as the Court thinks fit.
