A. DETAILS OF APPLICATION

This application is made under sections 444GA(1)(b) and 447A of the Corporations Act 2001 (Cth) (Act) and section 90-15 of the Insolvency Practice Schedule (Corporations), being Schedule 2 of the Act (IPS).

This is an application for orders for the compulsory transfer of all the issued capital held by the shareholders of Northern Iron Pty Ltd (Subject to Deed of Company Arrangement) (Receivers and Managers appointed) (ACN 646 998 772) (Northern Iron) to AG-River Energy Pty Ltd (ACN 668 020 693) (AG-River) or its nominee.

On the facts stated in the supporting affidavit(s), the plaintiff claims:

- 1. Pursuant to section 444GA(1)(b) of the Act (as amended by section 447A and pursuant to the order made by the Honourable Justice Hill on 10 October 2025 in COR 155 of 2025) for the purpose of satisfying the condition precedent at clause 10.1.8 of the deed of company arrangement executed in respect of Northern Iron, an order that Stuart George Reid and Samantha Rangika Sellahewa in their capacities as joint and several deed administrators of Northern Iron (**Deed Administrators**) have leave to transfer all of the issued shares (**Shares**) held by the members (as defined in the Act) in Northern Iron to AG-River (or its nominee).
- 2. Pursuant to section 447A(1) of the Act and section 90-15(1) of the IPS, an order that any of the Deed Administrators may, jointly or severally, in their capacities as Deed Administrators of Northern Iron:
 - (a) execute on behalf of the members any share transfer forms and any other documents ancillary or incidental to effecting the transfer of Shares referred to in Order 1; and

- (b) enter or procure the entry of the name of AG-River or its nominee into the share register of Northern Iron in respect of all Shares transferred to AG-River or its nominee in accordance with Order 1.
- 3. Orders that the plaintiffs have liberty to apply.
- 4. Such further or other order as this Honourable Court deems fit.
