NOTIFICATION TO CREDITORS

OVATO LIMITED ACN 050 148 644 AND ITS SUBSIDIARIES AS LISTED IN SCHEDULE 1 (ALL ADMINISTRATORS APPOINTED) (COLLECTIVELY "THE GROUP")

I refer to previous correspondence regarding the Group, in particular our correspondence dated 25 July 2022.

The Administrators made an application to the Federal Court of Australia on 27 July 2022, in relation to sections 443B(8) and 447A(1) of the *Corporations Act 2001 (Cth)* ("the Act") and section 90-15 of the *Insolvency Practice Schedule (Corporations) 2016*, to extend the period "within five business days after the beginning of the administration" in section 443B(3) of the Act instead to read "by 18 August 2022".

On 28 July 2022, the Federal Court of Australia granted the relief sought by the Administrators in their application. A copy of the Orders made by the Court and the Originating Process are attached to this notice.

The effect of the Orders is that the Administrators' personal liability under sections 443A(1)(C) and 443B(2) of the Act begins on 19 August 2022 and the Administrators' are not personally liable for any liability with respect of any property leased, used or occupied by the Group (including amounts payable pursuant to any leases entered into by any of the Group), from any lessors, in the period 21 July 2022 to 18 August 2022 inclusive.

Order 3 of the Orders made by the Court grants to any person who can demonstrate a sufficient interest liberty to apply to the Court to vary or discharge the Orders on three (3) business' days written notice to the Administrators and the Court.

A. DETAILS OF APPLICATION

This application is made under sections 443B(8) and 447A of the *Corporations Act* 2001 (Cth) (**Act**) and section 90-15 of the *Insolvency Practice Schedule (Corporations)* 2016 (**IPS**).

On the facts stated in the supporting affidavit(s), the First Plaintiffs seek the following orders in respect of the Second to Sixtieth Plaintiffs set out in the Schedule (**Companies**):

- 1. Pursuant to sections 443B(8) and 447A(1) of the Act and section 90-15 of the IPS, Part 5.3A of the Act is to operate in relation to each of the Companies as if:
 - a. the First Plaintiffs' personal liability under sections 443A(1)(c) and 443B(2) of the Act begins on 19 August 2022, such that the First Plaintiffs are not personally liable for any liability with respect to any property leased, used or occupied by any of the Companies (including amounts payable pursuant to any leases entered into by any of the Companies), from any lessors, in the period from 21 July 2022 to 18 August 2022 inclusive; and
 - b. the words "within five business days after the beginning of the administration" in section 443B(3) of the Act instead read "by 19 August 2022".
- 2. An order that the First Plaintiffs take all reasonable steps to cause notice of the Court's orders to be given and sealed copies of this Originating Process, within two (2) business days of the making of the orders, to creditors (including persons or entities claiming to be creditors) of each of the Companies.
- 3. An order that any person who can demonstrate a sufficient interest has liberty to apply to vary or discharge any orders made pursuant to paragraph 1 above on three (3) business days' written notice to the First Plaintiffs and the Court.
- 4. The Plaintiffs' costs of and incidental to this application be costs in the administration of each of the Companies, jointly and severally.



- 5. An order that the Court's orders be entered forthwith.
- 6. Any other order that the Court deems fit.
