CIRCULAR TO CREDITORS

I confirm at the second meeting of creditors of the Companies held on 22 December 2021, creditors resolved to wind up the Companies and John Park, Kelly-Anne Trenfield and I, Joanne Dunn, were appointed Joint and Several Liquidators of the Companies pursuant to Section 439(c) of the *Corporations Act 2001 (Cth)* ("the Act").
