VERDICT, ORDER OR DIRECTION:

- Black J grants leave to file in Court affidavit of Joseph Ronald Hansell dated 2 June 2025.

THE COURT ORDERS THAT:

The Court orders that:

- 1. Pursuant to section 439A(6) of the Corporations Act 2001 (Cth) (Corporations Act), the period within which the First Plaintiffs must convene the second meeting of creditors of each of the Second to Seventh Plaintiffs (Second Meeting) be extended up to and including 23 June 2025.
- 2. Pursuant to section 447A of the Corporations Act, notwithstanding the provisions of section 439A(2) of the Corporations Act, Part 5.3A of the Corporations Act is to operate in relation to each of the Second to Seventh Plaintiffs as if the Second Meeting may be convened and held, together or separately, at any time during the convening period, or within five (5) business days after the end of the convening period (as extended).

- 3. The First Plaintiffs are to take all reasonable steps to give notice of the orders made by the Court (including persons or entities claiming to be creditors) of each of the Second to Seventh Plaintiffs, in the following manner:
- (a) where the Administrators have an email address for a creditor, notifying each such creditor, via email, of the making of the orders and providing a link to a website where the creditor may download the orders; and
- (b) where the Administrators do not have an email address for a creditor but have a postal address for that creditor (or have received notification of non-delivery of a notice sent by email in accordance with sub-paragraph (a) above), notifying each such creditor, via post, of the making of the orders and providing a link to a website where the creditor may download the orders; and
- (c) placing scanned, sealed copies of the orders on the website maintained by the Administrators at https://www.fticonsulting.com/creditors/rcah-pty-ltd.
- 4. Any person who can demonstrate a sufficient interest has liberty to apply to vary or discharge any of orders 1-3 on three (3) business days' notice being given to the Plaintiffs and the Court.
- 5. These orders be entered forthwith.
- 6. The exhibit be returned.
