CIRCULAR TO CREDITORS

**RE: RGD Constructions Pty Ltd (In Liquidation) ACN 100 177 928; and

I refer to the appointment of Kelly-Anne Trenfield and I, John Park, as Administrators of the Companies on 8 May 2020.

I confirm at the second meeting of creditors of the Companies held on 12 June 2020, creditors resolved that each of the Companies be wound up.

Kelly-Anne Trenfield and I were appointed Joint and Several Liquidators of each of the Companies pursuant to Section 439(c) of the Corporations Act 2001 (*Cth*) (“**the Act**”).

The Liquidators are due to issue a report to the creditors of the Companies within three (3) months of the date of Liquidation which will, amongst other things, provide an updated estimated return to creditors.
