4. Goyx Pty Ltd (In Liquidation) (ACN 611 357 914) (**Goyx**);
5. Mondex Group Pty Ltd (In Liquidation) (ACN 165 224 064) (**Mondex**);
6. Newing Glacier Pty Ltd (In Liquidation) (ACN 600 515 857) (**Newing Glacier**);
7. Rocube Holding Pty Ltd (In Liquidation) (ACN 165 224 028) (**Rocube**); and
8. Spark Labour Solutions Pty Ltd (In Liquidation) (ACN 601 010 315) (**Spark**)
(collectively, the **Initial Companies**).

On 15 May 2019, the Federal Court of Australia ordered that each of the Initial Companies be wound up, and that Mr Allen, Joseph Hansell and myself be appointed as their liquidators. Mr Allen has since resigned as liquidator of the Initial Companies.

On 13 November 2019, Mr Allen, Mr Hansell and myself were appointed as the liquidators of LK Kimberley Pty Ltd (In Liquidation) (ACN 165 287 918) (**LK Kimberley**). Mr Allen has since resigned as liquidator of LK Kimberley.

On 3 March 2020, the Federal Court of Australia made orders that Mr Hansell and myself be appointed as liquidators of the following additional companies.

1. Big Mars Pty Ltd (In Liquidation) (ACN 155 091 179) (**Big Mars**);
2. Flying Sky Pty Ltd (In Liquidation) (ACN 164 814 617) (**Flying Sky**);
3. Shiny Star Trading Pty Ltd (In Liquidation) (ACN 160 842 759) (**Shiny Star**);
4. Johnson Group International Pty Ltd (In Liquidation) (ACN 144 731 662) (**Johnson Group**);
5. Darwin Investments Group Pty Ltd (In Liquidation) (ACN 142 983 480) (**Darwin**);
6. Koks Group Pty Ltd (In Liquidation) (ACN 625 505 786) (**Koks**); and
7. Scottwell International Pty Ltd (In Liquidation) (ACN 155 188 515) (**Scottwell**).

On 15 May 2020, the Federal Court of Australia made orders that Mr Hansell and myself be appointed as Liquidators of Lrbros Pty Ltd (In Liquidation) (ACN 611 356 042) (**Lrbros**), in addition to Big Mars, Flying Sky, Shiny Star, Johnson Group, Darwin, Koks, and Scottwell (collectively, the **Subsequent Companies**).

Mr Hansell and myself remain appointed as the liquidators (**Liquidators**) of each of the Initial Companies, the Subsequent Companies, and LK Kimberley (collectively, the **Companies**).

Following their appointment, the Liquidators have undertaken investigations into the affairs of the Companies. Additionally, on 22 November 2021, the Liquidators obtained a pooling order in relation to the Companies.

On 1 July 2022 the Liquidators filed an originating process in the Federal Court of Australia seeking orders for the issuance of summonses pursuant to sections 596A and 596B of the *Corporations Act 2001* (Cth) (**Act**). The originating process also sought orders addressed to various third parties for the production of documents relating to the examinable affairs of the Companies or some of them.

The Court has recently made orders for the issuance of the summonses and the production of documents. The Liquidators therefore provide this circular in accordance with section 596E of the Act, which requires that the Liquidators give written notice of the examination to (relevantly) as many of the Companies' creditors as reasonably practicable, where the Court summons a person for examination.

The Liquidators anticipate the production of documents will take place in November 2022, with the substantive examinations to follow in early 2023.
