In accordance with the enclosed *Form 534 Notice Inviting Formal Proof of Debt or Claim*, creditors have 21 days to submit particulars of their debts on or before **Friday 25 August 2023** or they may otherwise be excluded from a dividend.

SUPPLIER PURCHASE ORDERS

The Wiluna Group will continue to trade on "business as usual" basis in accordance with the DOCA.

During the deed administration, all purchase orders of the Companies will continue to require the authorisation from the Deed Administrators or their authorised representatives to sign purchase orders for the Companies as confirmed in our circular to creditors dated 19 July 2023.

ONGOING COMMUNICATIONS

We will continue to keep creditors appraised (via creditor circulars and ASX announcements) of developments and progress with respect to satisfaction of conditions precedent as outlined in the DOCA and intended dates for dividends to creditors.
