CROWDFUNDING PLATFORM

A crowdfunding platform had issues in ensuring the correct construction of a ledger, consolidated balance sheet and financial forecasting from their underlying data model. At that stage, the company required a supporting strategic partner to fill the roles of PMO, data mapping and data quality, model development, financial accounting and reporting experts.
