Economic Impact Analyses

To capture the full impact of a health system's ongoing operations, proposed new operations, construction, and investments, our analyses include both widely accepted metrics such as direct, indirect, and induced impacts, as well as innovative analyses designed to capture unique elements specific to the entity or proposed plan and the local healthcare market.



Our approach extends to innovative organizations, including investors in new enterprises, and recognizes the economic value of health systems across many dimensions, including clinical network integration, care coordination, medical tourism, and research programs with spillover impacts throughout the economy. Enhanced Population Health Assessments

Our enhanced population health assessments have been used by communities and collaboratives of civic, business, government, and healthcare leaders to understand costs and drivers of poor health and evidence-based methods and best practices for collective action to address them. We're experienced in Community Health Needs Assessments and foundational assessments for Medicaid reform. Our team works with extensive public data sources complemented by proprietary medical claims data to measure the prevalence of chronic and acute conditions, identify key factors driving medical costs, and quantify the impact of these conditions

on workforce productivity in specific communities and comparators. We use advanced modeling to evaluate the impact of potential interventions using new technologies, treatments or programs. The resulting analyses provide essential insight for stakeholders engaged in collaborative efforts and interventions to improve population health and economic and health returns. Building on advanced modeling, our team also creates tools that allow employers or other stakeholders to enter their own data and generate customized measures of the current cost of health conditions and potential gains from interventions.
