CASE STUDY

Global Anti-Corruption Pre-Transaction Risk Assessment Due Diligence

On behalf of a major United States passenger air carrier operating in over 50 countries on six continents, FTI Consulting performed pre-transaction bribery and corruption risk assessments in anticipation of the company's acquisition of several regional passenger air carriers located throughout Latin America.

FTI Consulting's assistance involved the acquisition and review of the target carriers' local language policy and procedure documentation pertaining to anti-bribery and anti-corruption systems and programs. In addition to the policy reviews conducted, FTI Consulting conducted interviews of relevant company personnel to further understand the existing controls in place to prevent and detect instances of bribery and corruption. FTI Consulting also performed selected transaction testing, targeted to the business transactions that are traditionally more susceptible to bribery and corruption risks. The work performed included data analysis to identify the higher risk transactions, selection of a sample of transactions for testing and the accumulation and review of local language documents supporting the transactions tested.

Our work resulted in the identification of gaps in the internal controls and existing bribery and corruption risks within the target's operating companies in Brazil and Colombia. Our findings were presented to the company's in-house compliance and transaction teams. For the work performed, FTI Consulting utilized personnel located in our offices in the United States and Latin America.

CASE STUDY

Global Anti-Corruption Consulting

After an FCPA enforcement action was brought by United States and foreign regulators, a global telecommunications services company turned to FTI Consulting to conduct in-country bribery and corruption investigations and risk assessments, as well as internal controls evaluation and remediation.

Our work included an analysis of the profits from contracts that regulators deemed to have been awarded pursuant to the payment of impermissible benefits to government officials. Critical to the success of the work was our us of professionals located in our offices throughout Europe and Asia, with appropriate language and technical fraud capabilities.

We also designed and implemented bribery and corruption risk assessment testing protocols across the company's local operating companies in countries throughout eastern Europe, central Asia and north Africa. The risk assessments included the identification and evaluation of existing bribery and corruption risks through targeted transactional testing and employee interviews conducted in-country. Additionally, FTI Consulting assisted the company in identifying and evaluating other fraud risks that may have existed within its local operating companies including risks of fraudulent financial reporting and risk surrounding the physical security of assets.

FTI Consulting also reviewed and evaluated existing internal controls and tested their operational effectiveness using process walkthroughs, gap identification and the development of remedial enhancements.

FTI Consulting was able to efficiently and effectively incorporate the results of the prior work into the scoping and in-country transactional testing protocols so as to avoid unnecessary replication of the work performed and to leverage prior findings and observations into our risk assessment activities.

We presented the results of our analysis of profits to regulators both in the United States and foreign regulatory agencies.



CASE STUDY

Global Pharmaceutical Anti-Corruption Investigation

FTI Consulting was retained by outside counsel to a multinational pharmaceutical company to investigate whistleblower allegations of improper payments made by sales representatives in China. FTI Consulting investigated over five years of employee expense reimbursements related to thousands of employees. FTI Consulting designed a methodology to risk-rank the activities of the sales force over the period of review, which counsel used to determine which employees should be interviewed. In addition, FTI Consulting reviewed expenses related to speaker fees, conferences, sponsorships, grants, training expenses and charitable contributions to determine if the expenses posed additional anticorruption risk. FTI Consulting's procedures included assisting counsel with forensic accounting procedures, structured data analytics, and investigative research. FTI Consulting's findings were presented to the DOJ and SEC, as well as to the external auditors and the board of directors.

CASE STUDY

Global Anti-Corruption and Pre-Acquisition Risk Assessment

FTI Consulting has been engaged since September 2010 by a global science and technology manufacturing company to perform proactive anti-corruption risk assessments for multiple wholly-owned subsidiaries in high-risk countries such as Brazil, Russia, Italy, India, China, Mexico, Turkey, and South Africa. FTI Consulting's procedures included conducting hundreds of interviews of in-country personnel and performing detailed testing of thousands of revenue and expense transactions to assess the potential level of corruption and bribery risk at each location. In many instances, we worked closely with general counsel and internal audit personnel and as a result of the risk assessment findings in one operating company, FTI Consulting worked with outside counsel to perform a more thorough anticorruption investigation which included a reputational due diligence review of certain third parties. In addition to the risk assessments and investigation, FTI Consulting assisted internal audit in the development of its anti-corruption audit program and interview templates. We also performed pre-acquisition due diligence reviews to determine the adequacy of anti-bribery controls and compliance culture for several significant pending acquisitions.
