CASE STUDIES

Government business review

FTI Consulting undertook an in-depth review of the NSW Government's Trustee and Guardian. This included:

- Assessed the costs, inputs and outputs for all of the activities and services provided.
- Built an activity based costing model and benchmarks to measure efficiency.
- Identified activities that were a CSO and those that are commercial.
- Identified means and options to fund all services.
- Recommended an approach to raise the financial sustainability of NSW TG in the next 5 years.
- This has shaped Treasury budget considerations and changes in prices applied to commercial services.

Independent review of consumer benefits

The review examined consumer benefits derived from a prepaid mobile minor cosmetic repair service. It used an approach that would be applied by a government regulator.

We identified and measured the main monetary benefits which relate to the cost effective means to repair minor cosmetic damage to members' new vehicles maintaining a new vehicle's aesthetics over the initial period of ownership.

We also identified many hard-to-monetise benefits. These include convenience, prestige, and peace of mind.

We substantiated that the performance of the provider was superior to loyalty schemes and add-on insurance. In our assessment it proved fair value to consumers.

Government owned corporation insurance review

The Review was initiated to gain an appreciation of the issues and practices affecting the insurance arrangements of Government Owned Corporations (GOCs) and like entities.

Our role was to prepare a report which evaluated the evidence of a policy problem and to evaluate options to address the problem.

We provided expert advice on framing the issues for the consultation workshop, prepared a presentation of the current state using the data collected during the review and drafted a concise policy report including options for consideration of senior management.
